

Privacy Policy

1. Part 1 – About this policy

1.1 Purpose

The Tribe Therapeutic Supports is committed to protecting the privacy of personal information we collect and hold about individuals. The Tribe Therapeutic Supports complies with the Australian Privacy Principles (APP) under the Privacy Act 1988 (Cth), other privacy laws that govern how the private sector health service providers like The Tribe Therapeutic Supports handle your personal information (including your health information), and The Code of Ethics and Practice for Developmental Educators and Counsellors.

This Privacy Policy explains how The Tribe Therapeutic Supports manages the personal information we collect, use and disclose. The Tribe Therapeutic Supports is a privately owned therapy support practice, and we will not use or disclose your personal information in any way other than those outlined in this document.

2. Part 2 – How The Tribe Therapeutic Supports handles your personal information.

2.1 The Tribe Therapeutic Supports legal obligations

In order to provide you with the therapy and support services that you have requested, The Tribe Therapeutic Supports will need to collect and use your personal information. If you provide incomplete or inaccurate information to us or withhold personal and health information from us we may not be able to provide you with the services you are seeking.

2.2 What information does The Tribe Therapeutic Supports collect?

The Tribe Therapeutic Supports will only collect the information required for the particular function or activity we are carrying out. We collect information from you that is necessary to provide you with Allied Health Services and to manage our relationship with you. The information we collect includes: your name, date of birth, address, your child's name and date of birth, information about your health history and/or your child's health history and family history. We require this information to assist our therapists to support you.

2.3 How does The Tribe Therapeutic Supports collect health information? We will usually collect your health information directly from you. Sometimes, we may need to collect information about you from a third party (such as from another therapy or health service provider).

2.4 How does The Tribe Therapeutic Supports use your information? The Tribe Therapeutic Supports uses your personal information for the purpose you have given the information to us. We will use your information to provide Allied Health Services to you, to manage our relationships with you and to contact you in relation to

matters concerning your care. We may also use your information for other purposes permitted under the Privacy Act 1988.

Who might we disclose information to?

We may disclose your information to the following people:

- a. Other health professionals involved in your treatment and/or care Your personal information will generally only be used by the Allied Health Professional involved in your care, however, on occasion your care may be provided by a number of health professionals (for example, Speech Pathologists, Occupational Therapists, Psychologists etc) working or consulting together. We may disclose your information to these health professionals as part of the process of providing your care and to other health professionals involved in your care.
- b. The referrer The Tribe Therapeutic Supports will usually send a discharge summary to the referrer (I.e. your medical practitioner) following discharge from The Tribe Therapeutic Supports or at other times, as required for your care.

If you do not wish us to provide a copy of your discharge summary to the referrer you must let us know. Also, if the details of the referrer have changed please advise your therapist from The Tribe Therapeutic Supports.

- c. Relatives, guardians or legal representatives

 We may provide information about the service you are receiving to a parent, other relatives, guardians, or to a responsible person for you, unless you tell us that you do not wish us to disclose your service information to any such person.
- d. South Australian Police or the Department of Child Protection We may disclose information about you or the children and young people under your care to the statutory authorities including the South Australian Police or the Department of Child Protection in relation to mandatory reporting obligations.
- e. Other uses and disclosures

In order to provide the best possible environment in which to treat you, we may also use or disclose your personal and health information where necessary for:

- Activities such as quality assurance processes, accreditation, audits, risk and claims management, patient satisfaction surveys and staff education and training;
- Invoicing, billing and account management;
- For the purpose of sending you standard reminders, for example for appointments and follow-up care, by text message or email to the number or address which you have provided to us.
- f. Other uses with your consent With your consent we may also use your information for other purposes

such as including you on a marketing mail list, or research. Please not, however, that unless you provide us with your express consent for this purpose, we will not use your information in this way. We will not disclose your personal information to any individual who is outside of Australia.

2.5 Access to an correction of your personal information

You have a right to access the personal and health information that we hold about you. You can also request an amendment to your personal and health information should you believe that it is inaccurate.

If we do not agree to change your medical record or personal information in accordance with your request, we will permit you to make a statement of requested changes and we will enclose this with your record. Should you wish to obtain access to or request changes to your health or information record you can ask for our Privacy Officer (see details below) who can give you more detailed information about The Tribe Therapeutic Supports access and correction procedure.

Please note that The Tribe Therapeutic Supports may recover reasonable costs associated with supplying this information to you.

2.6 Data Quality

The Tribe Therapeutic Supports will take reasonable steps to ensure that your personal information which we may collect, use or disclose is accurate, complete and up-to-date.

2.7 Data Security

The Tribe Therapeutic Supports will take reasonable steps to protect your personal information from misuse, interference, loss, unauthorised access, modification or disclosure. We use technologies' and processes such as access control procedures, network firewalls, encryption and physical security to protect your privacy. The Tribe Therapeutic Supports will destroy or permanently de-identify any of your information which is in its possession or control and which is no longer needed for the purpose for which it was collected provided The Tribe Therapeutic Supports is not required under Australian Law or court/tribunal or otherwise to retain the information. 2.8 What to do if you have a complaint about privacy issues If:

- a. You have guestions or comments about this Privacy Policy;
- b. The Tribe Therapeutic Supports does not agree to provide you with access to your personal information; or
- c. You have a complaint about our information handling practices,

 - 3. Part 3 How The Tribe Therapeutic Supports handles your personal information when you visit our website

This section of our Privacy Policy explains how we handle your personal information which is collected from our website. The Privacy Policy applies to your use of our website and the use of any of the facilities on our website.

3.1 Collection

When you use our website, we do not attempt to identify you as an individual user and we will not collect personal information about you unless you specifically provide this to us. Sometimes, we may collect your personal information if you choose to provide this to us via an online form or by email, for example, if you:

- Submit a general enquiry via our contacts page;
- Register to receive eNewsletters; or
- Send a written complaint or enquiry to our Privacy Officer.

When you use our website, our Internet Service Provider (ISP) may record and log for statistical purposes' the following information about your visit:

- Your computer address;
- The date and time of your visit;
- The pages and documents you access during your visit; and
- The browser you are using

Our website management agent may use statistical data collected by our ISP to evaluate the effectiveness of our website.

3.2 Cookies

A 'cookie' is a device that allows our server to identify and interact more effectively with your computer. Cookies do not identify individual users, but they do identify your ISP and your browser type. This website uses temporary cookies. This means that upon closing your browser, the temporary cookie assigned to you will be destroyed and no personal information is maintained which will identify you at a later date.

Personal information such as your email address is not collected unless you provide it to us. We do not disclose domain names or aggregate information to third parties other than agents who assist us with this website and who are under obligations of confidentiality. You may be able to configure your browser to accept or reject all cookies and to notify you when a cookie is used. We suggest that you refer to your browser instructions or help screens to learn more about these functions. However, please note that if you configure your browser so as not to receive any cookies, a certain level of functionality of The Tribe Therapeutic Supports website and other websites may be lost.

We may create links to third party websites. We are not responsible for the content or privacy practices employed by websites that are linked from our website.
